The relevant number of shares of Kværner ASA has been calculated into shares of Aker Solutions ASA based on the exchange ratio under the merger of the companies in November 2020. In accordance with the terms of the incentive program, the applicable value of each share received equals the volume-weighted average price of the Aker Solutions ASA share on Euronext Oslo Børs on the trading day before date of allocation, i.e. May 19, 2022 (NOK 32.0513 per share)
