

Dear Valued Partner,

Aker Solutions' purpose is to solve global energy challenges for future generations. In close collaboration with our customers and suppliers, we leverage our core capabilities to grow within renewables and transitional energy solutions. At the same time, we work systematically to reduce our emissions and optimize our energy use.

We wish to collaborate closely with you and other strategic partners and together forge a more sustainable future for our industry and the world it serves. As expectations and requirements to ESG are increasing, to remain competitive, companies must demonstrate transparency, consistency, and alignment throughout the value chain on all ESG ambitions and requirements. This includes accurate emissions reporting and working together to understand the total carbon footprint of a product's lifecycle.

In 2022, Aker Solutions defined energy and emissions requirements to be incorporated into project procurement contracts from January 2025 and onwards. We expect that you as a valued member of our supply chain take active steps towards meeting these requirements. Our aim is that the project-related share of Aker Solutions' supply chain is compliant with the following requirements:

Energy Management

We expect our suppliers to have an energy management system. This can be at various levels of maturity and can be fulfilled by meeting one or more of the following requirements:

- Certification in accordance with ISO 50001
- Adoption of ISO 50001 requirements and framework. Certification is not required.
- Energy policy and energy management plan in place and the ability to demonstrate energy efficiency. Certification is not required.

Carbon Emissions

We expect our suppliers to measure, monitor and have an improvement plan on carbon emissions. This can be fulfilled by meeting one of the following requirements:

- Commitment letter accepted by Science Based Targets initiative (SBTi) for all 3 scopes.
- Plan to set emissions reduction targets in line with SBTi for Scope 1 and Scope 2 and have a strategy to reduce Scope 3 emissions. SBTi commitment is not required.

Carbon Transparency

We expect our suppliers to be transparent on their carbon emissions and publicly report on emissions data through a 3rd party platform e.g. CDP or similar.

Product Emissions

We expect key suppliers of bulk metal, cement, and chemicals to provide Environmental Product Declaration (EPD) based on the ISO 14040/14044 or ISO 14025 standards or equivalent, for products requested by Aker Solutions. We expect suppliers to be compliant with any local and national emission reporting requirements and regulations.

Compliance

We encourage suppliers who already meet these requirements to provide the relevant information to Aker Solutions, even ahead of January 2025.

Please note that this is not an exclusive list of requirements. Additional requirements may be incorporated to meet specific Project, Segment and Company needs and/or as a result of changes in the regulatory framework.
